As the popularity of 2022 is known worldwide, JCI Bangalore Garden City gives you an Opportunity to take it to the next level and establish yourself as a future leader by learning the Art of long term Innings. As an LGB member you decide the projects and programs and the functioning of the LO. So what are you waiting for, fill the nomination paper and apply for the suitable /eligible post & create an impact.

Please find the attached nomination paper and guidelines to fill it.

1. The nomination form must be completely filled.
2. It should reach the Nomination Committee Chairman HGF Mitesh Lunia on or before 25th November 2022 before 05:00 PM by the candidate themselves.



3. It is mandatory for all contestants to attend the Interviews - date will be informed in due course
4. Elections will be held on 4th December 2022 - Sunday Morning
5. The contestants are hereby informed that a Candidate's Training School/ Interviews will be held which is mandatory to attend of which information will be shared immediately after last date of nominations

Rules & Regulations:

A. Eligibility Criteria:

#. For Director:

1. Candidates applying for the post of Director should have been a member for a minimum one (1) year. Only an EPS Graduate or a member who has taken one project as Project Director is eligible for applying for the post of Director. A member who has been a director twice is ineligible to apply for the same.

#. For Executive:

1. Candidates applying for the Executive's Post (Vice President, Treasurer, and Secretary) should have been a Director for at least one term. A member who has been an elected executive for three years is ineligible to apply for the same.

2. JCRT Chairperson and JCRT Secretary if she is an active Jaycee for 2 consecutive years shall be deemed to have completed the term of director on the leadership Ladder.

#. For President:

1. Candidates applying for the post of President should have been an elected Executive (Vice president, Secretary, Treasurer) at-least once to be able to contest.

NOTE :



1. The fees of the year 2023 should be paid by Cheque/DD only in favor of "JCI Bangalore Garden City" along with the nomination form @Rs.22000 incl. GST for Family Members & Rs.11000 for Individual Members as per the Membership Fee of 2022 which is subject to change as per the new team.

Please Note: Applications without Cheque & PAN card copy will be rejected.

The candidate should have no dues outstanding to the LO. Photocopy of ID proof with DOB & Address should be mandatorily enclosed with the nomination form.

2. One active member between the age group of 18-40 years can propose only 1 or second only 1 candidate for the post of Director or Vice-President. He can either propose or second only one candidate for the post of Secretary or Treasurer or President.

(For Clarification - Overall a member can Propose only once & Second Only Once.) Members between the ages of 18 to 40 years are only eligible to contest for election and /or cast their vote. **(Anyone born on and after 1st January 1983 can apply)**

3. Candidates can apply for a maximum of two posts in the Nomination paper & has to withdraw from any one post at the time of withdrawal announcement on or before the Election Day.

4. **Presence for Interviews and Elections is Compulsory**, if absent, letter of absence with the valid reason should be submitted by the candidate before that Particular Meet. It will be at the discretion of the Nomination Committee to accept or reject the letter of absence.
