General Terms and Conditions / Do's and Don'ts / Best Practices

1. Tap The Market, A project by JCI BGC is an initiative to bring all the businesses of members of JCI BGC closer and to promote the same through inter personal marketing by way of referrals.
2. All JCI BGC members Eligible to register for the event.
3. 2 Groups with unique categories will be created.
4. Categories will be based on Business/ Profession based on Goods and Services, Based on Type such as wholesale / retail etc.
5. No multiple members in one category will be allowed in the same group, provided all parameters set and mentioned above are same.
6. One Business, One Member only i.e., 2 members can not represent 1 business and No member can represent 2 businesses.
7. All members whether registered with TTM earlier or not will have to Re-Register based on acceptance of this document.
8. Selection of a member will be done based on the below mentioned parameters.
 - First priority to already registered active members of TTM followed by Existing Waitlist members, then followed by members who have joined JCIBGC in 2nd Half, followed by all other existing members of JCIBGC for the year 2021.
 - First Come, First Serve for the category specific based on registration and payment process completed and should satisfy the condition in point no 1.
 - Cut-off Date will be 6.00 PM on 29th Aug 2021 for TTM members to claim their preference, cut-off dates for rest will be 30th Aug 2021. No Registration will be taken under any circumstances post 30th Aug 2021.
 - Member can alter his category of business if he deals in multiple line of products or business verticals to join the Group.

15. The JCI BGC Business Bot – TIA (Thanks In Advance) will be opened to all members of JCIBGC in future, all TTM members will be given multiple preferences in the same.
16. Promotion through social media handles will be done based on production of creatives given by the members or developed by team from time to time based on Reponses and data accuracy provided by the members.
17. Meeting Agenda, Privileges etc will be shared by the Team 3-5 days before every meeting.
18. Members not attending meeting will have to inform at least 5 days in advance of the meeting. Except for any serious medical emergency to the member or his immediate family no last-minute excuse will be entertained.

Member missing the meeting without reason will be notified, Member has to inform the team the reason within 2 days from receiving such notice, upon satisfactory reason member will be allowed to continue further. In case the reason is found unsatisfactory by the team; the category of such member will be reopened and member will be replaced by another member. No refunds of any amount collected from the member removed will be given. New member replacing the member will pay on Pro Rata Basis as informed by the team while joining.
